FCC Okays BPL Proposal

The FCC has unanimously approved a Notice of Proposed Rule Making (NPRM) to deploy Broadband over Power Line (BPL). The NPRM is the next step in the BPL proceeding, which began last April with a Notice of Inquiry that attracted more than 5100 comments—many from the amateur community. The FCC did not propose any changes in Part 15 rules governing unlicensed devices, but said it would require BPL providers to apply "adaptive" interference mitigation techniques to their systems. An ARRL delegation that included President Jim Haynie, W5JBP, attended the FCC open meeting in Washington, and later expressed disappointment in the FCC action. "The Commission clearly recognized that the existing Part 15 emission limits are inadequate to stop interference, but it's placing the burden of interference mitigation on the licensed user that's supposed to be protected," said ARRL CEO David Sumner, K1ZZ.

Sumner said that if the FCC really believed current Part 15 emission limits were sufficient, it would not have had to require that BPL providers institute interference mitigation systems. The FCC has not yet released the actual NPRM, and a presentation by the FCC's Office of Engineering and Technology (OET) revealed only its broad outlines. Sumner said the League would not take a formal position until it reviews the full NPRM.

Anh Wride of the OET staff spelled out the scope of the NPRM, which only addresses so-called "access BPL"—the type that would apply radio frequency energy to exterior overhead and underground low and medium-voltage power lines to distribute broadband and Internet service. She said the OET staff believes that interference concerns "can be adequately addressed." Wride said the FCC's BPL NPRM:

* Applies existing Part 15 emission limits for unlicensed carrier-current systems to BPL systems. Part 15 rules now require that BPL systems eliminate any harmful interference that may occur "and must cease operation if they cannot," she noted.

* Requires BPL systems to employ "adaptive interference-mitigation techniques, including the capabilities to shut down a specific device, to reduce power levels on a dynamic or remote-control basis and to include or exclude specific operating frequencies or bands."

* Subjects BPL providers to notification requirements that would establish a public database to include such information as the location of BPL devices, modulation type and operating frequencies.

* Proposes guidelines to provide for consistent and repeatable measurement of the RF emissions from BPL and other carrier-current systems.

Mirroring his colleagues' enthusiasm, FCC Chairman Michael Powell called BPL "tremendously exciting." While conceding that BPL has "a long way to go," the chairman said it could be "the great broadband hope for a good part of rural America." Powell also said the FCC's OET has worked very hard to try to "get their hands around" the issue of interference and that the FCC would continue its vigilance in that area.

The FCC is expected to issue the complete Notice of Proposed Rule Making within a few days and will invite comments on it sometime after its publication.

INTERNET REMOTE Ham Radio Adventures

Greetings from Oakville, Washington

When I read my February 2004 issue of the In-Service, I wanted to thank the In-Service staff, and writers Eric Santon KJ0D, and Terry Redding W6LMJ for the articles about operating Internet Remote. I decided to try it out and thought I'd share my experiences.

First I went to <http://www.w4mq.com/> which was mentioned in Terry's article. The website shows 5 different sites that provide Internet Remote access to their stations. I went to each site to find out more about the stations. The control operator's picture was on the N4OLT site and he looked very familiar. A quick trip to a Callsign lookup engine revealed the control operator was none other than Terry Redding. His article had said he was considering setting up remote access to the olt.net corporate club station. Well it's up and running.

The software needed to operate the remote stations is provided on the W4MQ website. I started downloading the software and sent Terry an e-mail. I explained that not only was I interested in experimenting with the technology, I'd also just moved and was currently without a station. He told me the station was going to be receive only for non-corporate club members, but as it turns out, ASCRA members are considered associate members. We setup a password and I was authorized to use the station, which is a Kenwood TS2000 connected to a 10-40 meter dipole and a 146/440 MHz vertical.

The download was now done. You get what you pay for, and this is freeware. I was expecting configuration nightmares. So I took a deep breath and ran the install software. It went smoothly enough and created a desktop icon. Another deep breath and I clicked the icon. I was expecting the usual corrupt or missing file error messages. Instead, this nice clean little interface popped up that looks a lot like a radio. I spun the knob and pushed a few buttons, or the interface equivalent. There's good documentation so I won't explain how the controls work.

OK the knobs spin and the buttons push. I entered call sign and password in the windows labeled ... callsign and password. I took yet another deep breath, and pushed the login button labeled login. My speakers came to life and I was in.

I listened to several bands, switched to different modes, fiddled with the squelch, and kicked the tires. The audio was good. It was just plain fun.

One of the available modes is PSK. I've done some reading about PSK, it looks interesting but I'd never tried it. Up till now things had gone way too smoothly and I figured I'd finally run into some problems when I tried to make the PSK software work with the Internet Remote

software. No such luck! The PSK software is already integrated into the Interface. You go into PSK mode and another window comes up that has everything you need to operate PSK. If you want to know more about PSK go to <http://www.google.com/> and search for PSK31. It's a fun digital mode, and works a little like an Internet Chat session.

There is a 60 minute limit on your session. After that you're supposed to get off and let someone else have a turn. From what I could tell, once your time is up, you don't get cut off, but if someone logs in, you'll get booted off the air. I'm not sure about that but, I did get booted off once by someone logging in as guest. Also, while watching a PSK QSO for several minutes, I got an inactivity warning and was told I'd be logged off unless I entered a command. I adjusted the squelch, and it left me alone.

If you have a station in your den, you don't need this. But you should try it just for fun. On the other hand, if your current situation is such that you don't have a station, this is a great way to get on, or back on, the air. You need a PC and an Internet connection. That's it. You will need to install some free software so a public PC, a library PC for instance, is probably out of the question. But, if you can come up with an old PC, you can probably make this happen. If you've got friends that are interested in Ham Radio, but are put off by the cost of a station, they can get started for nothing now. You don't even need a Ham license to use some of the remote stations in receive mode.

Try it out and send me an email telling me what you think. I'm going to go log in to my station in Florida. I might even get on the air this time.
